

## The Story of the Standards

We have now completed the Charter for Social Pedagogy and the Standards. Some people have asked why we have both a Charter and Standards. The Charter is there for all members of the Social Pedagogy Professional Association to sign up to. It is a general statement of values and ethics that apply to all members in their daily life as well as social pedagogy practitioners. The Standards provide the frame for the qualifications we are developing in social pedagogy. They are the reference point for all social pedagogy diplomas.

We thought you might also like to know how we arrived at the Charter and the Standards. We have consulted and edited in an iterative process. We invited members of SPDN to a consultation event for around 40 people on 4 April 2016 with the Crossfields Institute, who are our qualifications development partners. The attendees worked on identifying values and principles for social pedagogy.

- These statements were recorded and shaped into draft format and brought to the project core group of Jacaranda, Thempra, and UCL IOE representatives on 11 and 12 April.
- Crossfields then developed these revised statements into a SurveyMonkey questionnaire that was sent out to those on the SPDN database for comment during May 2016. There were 70 responses with a high degree of agreement among those responding. Nearly all (97 per cent) agreed that the draft charter expressed the value base of social pedagogy. There was also a very high level of agreement that the statements in the two parts of the standards (Part 1 Philosophy and Haltung; Part 2 Practice) were essential or desirable in social pedagogy. There were some critical comments and these were woven in, in the next iteration, mostly to try to avoid repetition or lack of clarity and in some cases to introduce new topics.
- The revised draft Charter and Standards went to SPDN in Aberdeen on 10 June for a final review. Two open space forums were held, where all comments were noted.
- A final version, incorporating all comments, so far as possible, was agreed by the project core group, on 16 June.

We said during the consultation period that we envisaged the Charter and Standards as being open to renewal. For this we anticipate a two month period of revision each year. We will bring you more details on this when we can.

## What's next for SPPA?

The autumn will be busy for SPPA.

- Anticipated launch of SPPA in November 2016. So we will be open for members!
- Introducing our first Level 3 qualification. This will mean that those people who have completed training with our Centres – Jacaranda and ThemPra – will be able to register for accreditation at Level 3. More details of this initiative will be coming out soon, including details about assessment requirements.
- Developing Standards for Education and Training so that those organisations that offer social pedagogy training and meet the Standards can become registered with SPPA.
